



MEETING MINUTES - TUESDAY, JULY 5, 2022

President Eric Rowe called the meeting to order at 11:00 am in the Student Activities Room at the high school. Nine association members attended, as did SASD Superintendent Dr. Frank Jankowski.

Minutes – June 8, 2022: - Kim Rowe made a motion, seconded by Charlie Benner, that we approve the minutes of the June 8 meeting as written. The motion PASSED.

Treasurer's Report: Kim Soper reported a checking account balance of \$2,577.33 and a Seals Legacy Fund balance of \$20,599.64. Dennis Wolfe made a motion, seconded by Kim Rowe, that we accept the treasurer's report. The motion PASSED.

Membership: Since June 1 we have received four new memberships.

Administrative Updates:

1. **High School:** Principal Dr. Matt Conrad was unable to attend the meeting.
2. **District:** Dr. Jankowski reported that the district administrative team held a retreat in early June. He received our "ceremonial" check presentation from our Legacy Fund golf tournament donation. The Board of Education supports the elementary school playground project, but the project has been delayed because of supply issues. The new electronic sign has been installed on Broad Street. All messages that are displayed on the sign must be approved by Dr. Jankowski. Stadium light upgrades will be done in late July. The old lights have a historical significance because of their previous location in Sunbury. It will be costly to restore and repurpose them.

Association Activities:

1. **Homecoming / Banquet:** We are still awaiting the completion of the flyer to invite alumni artists to share works for display at the banquet.
2. **Distinguished Alumni Award:** As of the June 30 deadline, we have received four nominees. Lowell Leitzel made a motion, seconded by Dave Hess, that we select a maximum of three Distinguished Alumni Award recipients each year. The motion PASSED. Charlie Benner made a motion, seconded by Patti Morris, that we select Marvin L. Brubaker as a 2022 Distinguished Alumni Award recipient. The motion PASSED. Kim Soper made a motion, seconded by Shawn Felty, that we select John Gallagher as a 2022 Distinguished Alumni Award recipient. The motion PASSED. Kim Soper made a motion, seconded by Shawn Felty, that we select Mike Bennett as a 2022 Distinguished Alumni Award recipient. The motion PASSED. Eric Rowe will contact each of the recipients via letter and follow-up phone call.
3. **Hall of Fame:** Dave Hess had no update. The selection committee is in place.
4. **Golf Tournament:** In two weeks Eric Rowe and Dave Hess will begin in-person solicitations for golfers and sponsors. Some revisions were made to the draft of the promotional flyer. Suggestions were made about gifts and prizes for the golfers.
5. **Website:** Updates will be made concerning the golf tournament.

New Business:

1. Dennis Wolfe reiterated the need to recruit younger members for the association and to get younger alumni more actively involved. We discussed some ways to do that.
