Administrative Updates:

First through fifth place winners move on to state competition. That same day the Seals wrestling team won the District 4 team duals title by defeating Shikellamy. In music, fifteen SAHS chorus members have advanced from District Chorus to Regional Chorus. "Shrek, the Musical" will be presented on March 1, 2 and 3. English IV students recently participated in a Renaissance Faire field trip, with one earning a grand prize and another earning third place in their respective competitions.
- District:** Dr. Jankowski noted that positions of Business Manager and Head Football Coach are vacant. Applications are now being received. After the completion of a budget needs analysis, he hopes to be able, at our March meeting, to provide us with some options for our 2023 golf tournament proceeds donations.

Association Activities:
