



MEETING MINUTES - FEBRUARY 3, 2025

President Eric Rowe called the meeting to order at 11:00 am in the Student Activities Room at the high school. Nine association members attended, as did SAHS Principal Dr. Matt Conrad and SASD Superintendent Dr. Frank Jankowski.

Minutes - January 13, 2025 Kim Rowe motion, Kim Soper second, that we approve the January 13 meeting minutes as presented. The motion PASSED.

Treasurer's Report: Kim Soper reported balances of \$24,847.47 in the checking account and \$20,232.86 in the Seals Legacy Fund. Lowell Leitzel motion, Terry Heintzel second that we accept the Treasurer's Report. The motion was PASSED.

Membership: No update. Eric Rowe informed the committee that Dennis Wolfe is taking a leave of absence from our association meetings and activities.

Administrative Updates:

1. **High School:** Dr. Conrad reported that the spring musical, *Mamma Mia!*, will take place on February 28 and March 1 and 2 in the middle school auditorium. Tickets are available online. Winter sports are concluding their regular seasons, with senior recognition ceremonies taking place. Course scheduling for next year is underway. Chorus, band and modern ("classical rock") band programs have been taking place at the district level. A Susquehanna Valley Band concert was held recently. The graduation date is set for Thursday, May 29.
2. **District:** Dr. Jankowski informed us that he chairs the Business Education Committee of the Greater Susquehanna Valley Chamber of Commerce. They will sponsor a multi-district (for SUN Tech area schools) career fair in the Garrett Sports Complex at Susquehanna University on March 5.

Association Activities:

1. **Brochure insert:** We reviewed the brochure text proposed by Eric Rowe and Kim Soper and made a few editorial changes. Shawn Felty will work on producing the folders and brochures.
2. **Distinguished Alumni:** We have three nominations in hand, with the fall banquet theme being "Community Service and Engagement."
3. **Sports Hall of Fame:** Dave Hess reported that the selection committee has set meeting dates for February and March. The nominations deadline is March 1. A three-person display committee has been formed. The induction ceremony will take place on May 17.
4. **Golf Tournament:** The date of Friday, October 10, has been reserved at the Susquehanna Valley Country Club.
5. **Tax-exempt status:** Eric Rowe is working on the application paperwork. A \$600 fee will be required.
6. **Memorabilia Display:** Mr. Aument is scheduled to begin to work on this project after the conclusion of the school musical.
