



## MEETING MINUTES - MAY 5, 2025

President Eric Rowe called the meeting to order at 11:00 am in the Student Activities Room at the high school. Eight association members attended, as did SAHS Principal Dr. Matt Conrad.

**Minutes - April 7:** Brandy Savidge motion, Patty Morris second, that we approve the April 7 minutes as presented. The motion PASSED.

**Treasurer's Report:** Kim Soper reported a checking account balance of \$9,992.36 and a Seals Legacy Fund balance of \$35,158.08. Kim has paid the \$600 tax-exempt application fee, and Eric has received the application for space at the Market Street Festival. Lowell Leitzel motion, Sue Herrold second, that we accept the report as presented. The motion PASSED.

**Membership:** We have received one new membership.

### Administrative Updates:

1. **High School:** Dr. Conrad reported that the prom on May 3 was a success. The event had a Las Vegas theme, and Lily Boyer and Mason Dressler were chosen as prom royalty. The mixed chorus/honors choir concert took place on May 2, with four seniors featured as soloists. Upcoming concerts include the band (May 8), the show choir (May 9) and the chorus "Cabaret Concert" on May 16. AP Exams begin this week, and the spring Keystone Assessments will begin on May 12. The graduation ceremony will take place at 7:00 pm on Thursday, May 29, at the stadium. The rain date will be the following evening.
2. **District:** Dr. Jankowski was unable to attend, so we received no district-level updates.

### Association Activities:

1. **2024 Golf Tournament proceeds:** We have not yet received any recommendations for the use of those proceeds.
2. **Association folder/brochure:** Kim and Eric shared the proof of these documents. Selinsgrove Ford will pay to have 100 of them printed for distribution at local businesses. We might switch some of the photographs.
3. **2025 Distinguished Alumni:** We have received four nominations, with the nomination deadline being June 1. Eric shared design proposals for the display wall, including a header plaque and the individual honoree plaques.
4. **Sports Hall of Fame:** Dave Hess is organizing the details for the May 17 induction ceremony. Eric Rowe will serve as Master of Ceremonies. We just received \$650 for program ads for the event.
5. **2025 Golf Tournament:** The date is October 10. There are no updates at the present time.
6. **Tax-Exempt Status:** We have paid the application fee. Approval is still being processed.
7. **Graduation Ceremony:** Eric has ordered additional Seals stress relievers to give to the graduates at ceremony. We will need three or four volunteers to help distribute them.
