



MEETING MINUTES - MONDAY, AUGUST 5, 2024

President Eric Rowe called the meeting to order at 11:05 am in the Main Office Conference Room at the high school. Eight association members attended, as did SAHS Principal Dr. Matt Conrad and SASD Superintendent Dr. Frank Jankowski.

Minutes - June 10: Patty Morris motion, Sue Herrold second, that we approve the June 10 minutes with two spelling corrections. The motion PASSED.

Treasurer's Report: Kim Soper reported a checking balance of \$9,326.50 and a Seals Legacy Fund balance of \$19,320.14. Lowell Leitzel motion, Dennis Wolfe second from, that the treasurer's report be accepted as presented. The motion PASSED.

Membership: Dennis Wolfe had no update to report.

Administrative Updates:

1. **High School:** Dr. Conrad reported that fall sports teams and the band are returning to practices. The building is ready for teachers to report on August 19 and students on August 21. Emily Hornberger, a 2024 graduate, has received a \$3,000 Dairy Leaders of Tomorrow Scholarship to attend Penn State University to study animal science.
2. **District:** Dr. Jankowski reported that the district has received our golf tournament donation for the physical education mats and the art kiln. The storage and parking area behind the high school has been renovated and paved. New teachers will begin their orientation on August 13. The intermediate school will have a new playground. New scoreboards are being installed on the baseball, softball and soccer fields. A new flagpole is being installed at the stadium. A K-12 pep rally will be held at the stadium on September 13.

Association Activities:

1. **Alumni Banquet:** The banquet date is Saturday, October 26, to be held in the high school cafeteria. We still need to select the menu and set the price before tickets can be printed. We will also need raffle items.
2. **Distinguished Alumni:** All five awardees have accepted. We have no update on the distinguished alumni wall display.
3. **Sports Hall of Fame:** We have received no update from Dave Hess.
4. **Golf Tournament:** The tournament will be held on Friday, October 4. We have received a \$1,500 sponsorship for the carts. The hole sponsorship fee is \$200.
5. **US flag in the gymnasium:** The flag has been installed.
6. **Association brochure:** Dennis Wolfe reported that Todd Benner is willing to sponsor ads on the proposed brochure for \$900. Terry Heintzleman motion, Kim Soper second, that we pay the balance needed (about \$60) to create new membership brochures. The motion PASSED.
7. **Association logo:** Eric Rowe will follow up with the graphic arts instructor, Mr. Jarrett.
8. **Media Center Alcove Alumni Displays:** Eric will follow up with Mr. Aument.
